From Rowena Sloan, a direct descendant:

Stephen Hover was christened on 21 March 1790 at Warbleton Parish Church (his parents Stephen Hover and Jemima Gurr had been married in the same church on 4 October 1789). He married Harriet Wratten on 21 February 1814 at the age of 23/24. They had two daughters – Harriet in 1817 and Caroline in about 1819, both baptised in the independent Baptist Chapel (their mother's religion). A son "Jabez" was christened in February 1822 (just after Stephen's arrival in NSW).

Trial information per Rowena Sloan:

"In the April 1821 Stephen went out in the night and stole a hen from a local land owners farm (named Jesse Smith) and then another cock and hen from a farm also owned by Jesse Smith in Herstmonceux. The witness statements give detailed accounts of this. His trial would have been at Lewes but it was moved to Hastings. He pleaded Not Guilty to both charges and the jury found him 'not guilty' of stealing the cock and hen from herstmonceux so he was aquitted, but they did find him guilty of stealing the hen from Warbleton, so they had him transported for 7 years."
